Good day.

The Local Water Utilities Administration (LWUA) has granted provisional approval for a **38% adjustment** in water rates for the Metropolitan Cebu Water District (MCWD), which will reflect in consumers' bills starting March 1, 2025. With this provisional rate, the **Power Cost Adjustment (PCA)** and **Purchased Water Adjustment (PWA)** charges will no longer be listed separately on the bill, as they are now included in the Water Fee charges.

Below are the LWUA-approved provisional water rates for MCWD:


